



Webinar - Changes to the Margin Protection Program for Dairy Farmers

A “new” look worth considering!

This is an extremely busy time of the year. With a pending June 1 deadline and to save you time and provide critical information about the Margin Protection Program (MPP), this webinar is offered through a joint effort of the Missouri Farm Service Agency (FSA), the University of Missouri Extension, and the Missouri Dairy Industry Alliance.

Listen in on the webinar as **Joe Horner and Scott Brown**, University of Missouri Extension and **Lisa Allen**, Missouri Farm Services Agency, explain the changes to the MPP and help you make an informed decision about participating this year.

The new signup allows dairy producers, including those that previously signed up and those that did not, an opportunity to make new elections for 2018. Coverage begins January 1, 2018. ***If you previously elected coverage for 2018, you must make a new coverage election for 2018 during the current new sign up period.*** If you do not make a new election you will not have coverage for 2018. The new sign up deadline is June 1, 2018.
